Communications

SOESD Superintendent's Schedule of Meetings

Superintendent Beveridge reviewed his schedule of meetings for the months of November 2019, December 2019 and January 2020. Mr. Beveridge noted that his calendar included:

- November 4, 2019: A meeting with Karla McCafferty, Executive Director of Options for Southern Oregon, and Peter Buckley, Southern Oregon Success (SORS) Program Manager, to discuss mental health and behavior supports for students.
- November 13, 2019: Superintendent Beveridge attended a statewide meeting with Miriam Calderon, ODE Learning System Director, discussing substantial changes in Preschool Promise awards. Although a shift may be made in how dollars flow to preschool providers, Mr. Beveridge does not anticipate those changes will result in a reduction of Southern Oregon's Early Learning Hub staff.
- Superintendent Beveridge meets regularly with Charlie Bauer, Migrant Education Coordinator, and Patty Michiels, HR Manager, to continue Diversity, Equity, and Inclusion (DEI) planning. A DEI policy is being drafted and will be brought to the Board for a first reading after the new year.
- Superintendent Beveridge participates in regular technology planning meetings with Klamath Falls City Schools overseeing expanded network service support that has been requested by the school district.
- Superintendent Beveridge will meet regularly with Coree Kelly, who joins the SOESD Administrative Team on December 3, 2019 as Chief Information Officer beginning part-time. Mr. Kelly will fill the position full-time beginning December 16, 2019.
- Licensed contract mediation takes place on December 3, 2019.
- Strategic planning meetings are scheduled throughout the months.

Ms. Ryder provided an overview of the report, noting there were no issues or items of non-compliance found in the agency's audit. B. Southern Oregon Early Learning Hub Contract Amendment

At the September 18, 2019 SOESD regular meeting, the Board approved a request to increase Preschool Promise contracts to ensure Preschool Promise programs are able to deliver services for the 2019-20 school year, in alignment with Early Learning Division expectations and guidelines. These amounts are estimates at the time budgets are determined. Due to increased operating costs for the school year, Roots and Wings Community Preschool has a need for an additional \$598.64. Administration recommends the board approve this request to ensure all operating costs associated with delivering Preschool Promise are included in the contractual agreement.
