### SOESD Superintendent's Schedule of Meetings

#### **Education Topics**

#### Southern Oregon Early Learning Services (SOELS)

René Brandon, SOESD Early Learning Hub Director, provided an overview of the mission and vision of Southern Oregon Early Learning Services (SOELS). Ms. Brandon explained that SOELS partners with community providers to work toward the three primary goals which every Early Learning Hub in Oregon is charged to achieve:

- 1) Aligned and Coordinated Early Learning System
- 2) Healthy, Stable, and Attached Families
- 3) Children Arrive at Kindergarten Prepared and Supported for Success

#### Administration

#### A. Revised Meeting Schedule

A revised schedule of regular board meetings for 2018-2019 was presented for formal approval. The November 21, 2018 regular meeting has been changed to Wednesday, November 28, 2018 due to the Thanksgiving Day holiday.

#### B. 2019-2020 Local Service Plan (LSP)

Superintendent Beveridge provided an overview of the timeline and an update on the process for approving the 2019-2020 Local Service Plan (LSP). By statute, the Local Service Plan must be approved on or before March 1 by at least two-thirds of the component school districts with a majority of the student enrollment.

Superintendent Beveridge shared a shift he has proposed in the way the LSP has historically been developed. Rather than meeting with the region's school district administrators in fall to determine their needs for new services that aren't planned until the next school year, SOESD plans to have conversations with the districts about their needs in early spring to aid in service selections and to be more responsive with providing services for the fall.

Superintendent Beveridge and Business Manager Weaver clarified that the Local Service Plan offers districts a structure from which to choose services. In approving the plan, local school district boards have made rolling three-year commitments to their selections within areas of School Improvement and Technology, while Special Education services continue to be selected annually. Mr. Weaver described the systems for tracking service data across all program areas. Mr. Beveridge reported the LSP may be ready for board approval soon.

#### C. Superintendent's Goals for 2018-2019

Superintendent Beveridge presented a draft of his goals for the 2018-2019 fiscal year. Mr. Beveridge explained that he had prepared his goals to align with the work identified in the SOESD's Strategic Plan. The Board discussed potentially adding a leadership goal for professional development.

IT WAS MOVED BY MEMBER JENSEN, SECONDED BY MEMBER CONVERSE TO:

Approve Superintendent Beveridge's 2018-2019 goals as presented with the idea that after the work session on November 29, the Board may add a personal goal at that time.

Superintendent Beveridge asked board members to prepare for the session by thinking about the development of the 2020-22 strategic plan and the work they would like to include when developing that plan in 2019-20.

Business Manager Weaver presented the proposed 2019-2020 budget year calendar and provided an overview of the timeline. Mr. Weaver stressed that it is important for Board members to attend the Budget Committee Meeting on May 8, 2019.
