#### Administration

A. Ratification of the 2019-2022 Collective Bargaining Agreement between Southern Oregon ESD and the Southern Oregon Bargaining Council

A tentative agreement with the licensed association to settle the 2019-2022 Collective Bargaining Agreement was provided to the board in advance of the meeting for their review.

B. Approval of Licensed Job Description: Board Certified Behavior Analyst A new licensed job description, Board Certified Behavior Analyst, was presented for approval. Superintendent Beveridge explained that the position aligned with the expressed needs of the region's districts and work providing mental and behavioral health support.

Approve the Board Certified Behavior Analyst licensed job description as presented.

C. Update to Administrator and Confidential Employee Compensation, 2020-2022

Board approval was requested to increase the district's contribution from \$300 to \$350 for administrators or confidential employees opting out of medical, dental, and vision insurance. Business Manager Weaver explained that the \$50 increase per month aligned with the terms negotiated in the agreement with the SOESD licensed association.

## IT WAS MOVED BY MEMBER MANNENBACH, SECONDED BY MEMBER WRIGHT TO:

Approve increasing the district's contribution to \$350 per month for administrators or confidential employees opting out of district-provided insurance.

D. Compensation for SOESD Superintendent, 2019-2022

The proposed increase in compensation for the SOESD Superintendent was provided to the board in advance of the meeting for review and consideration. Business Manager Weaver explained that the proposed terms were the same as the compensation for administrators and confidential employees approved by the board during the May regular meeting, except that the district's contribution for opting out of insurance benefits had been increased to \$350 per month.

Approve the 2019-2022 compensation for SOESD Superintendent as presented.
