**Philosophy and approach**: OnTrack's treatment philosophy is based on the ten guiding principles of recovery, which emphasize person-centered, strength-based, holistic, respectful treatment and support.

We practice universal trauma precautions and strive to help individuals identify their strengths, learn new skills, and overcome barriers to leading a productive, meaningful life.


We utilize evidence-based practices to treat addiction while recognizing that long-term recovery is sustained through health, connectedness, hope, purpose, self-efficacy and having a safe home.

Our treatment services are delivered through a continuum of services and care coordination that addresses the physical, psychological, social, and cognitive needs of clients and their families.

## Where are we located?

- We have outpatient office locations in Medford, Grants Pass and Cave Junction.
- We have three residential treatment facilities:
  - The HOME program for pregnant and parenting women Medford
  - Dads program Medford
  - Grants Pass/Hugo adults only
  - We have approximately 250 units of transitional, lowincome, second-chance or permanent housing throughout the Rogue Valley.

- Medication-Assisted Treatment (MAT) supportive counseling (we collaborate with OASIS and Birch Grove for MAT for our clients)
- Family Counseling for substance abuse
- Spanish services available in DUII and A&D counseling (Medford)

## Our Residential Treatment Facilities HOME Program (a.k.a. Mom's Program)



- State-licensed, residential substance abuse program serving mothers and their children, with capacity for 25 pregnant or parenting mothers with children ages newborn to 5 years of age.
- Capacity slightly reduced during COVID-19 and due to staffing shortages.
- The goal of our residential treatment is to provide a safe environment for residents to obtain
  necessary skills to stabilize and reduce symptoms, with the overall goal to decrease level of care.
  Completion of residential treatment is individualized, based on the client's identified goals, and is
  continuously evaluated by the client and his/her treatment team.



## Our Residential Treatment Facilities Dad's Program



 State-licensed, residential substance abuse program serving custodial fathers and their children (Pre-K and under) with a 10-bed capacity. Through intensive residential treatment for fathers and their children, this service gives men a chance to rebuild their lives and become capable, caring parents.





## Our Residential Treatment Facilities Mountain View Recovery Co-ed Adult Program

- Providing a safe, supportive, substance-free living environment during early recovery while helping clients to become responsible, effective parents, partners and family members.
- This co-gender facility is licensed to accommodate up to 24 individuals and is an integral part of our network of services offered in Josephine County.

## Referrals and Admits to Residential Facilities



- All residential programs are currently running waiting lists. This is not unusual, and lists can change quickly.
- A typical client stay is 90-120 days.

#### Peer Support Services



OnTrack believes that Peer Support is an important, distinct component of mental health and substance abuse services. Our trained Peer Support Specialists have a unique capacity to support clients based on a shared affiliation and a deep understanding of this experience. Because of this affiliation and understanding, the peer team can support individuals in their recovery and the challenges they may face in overcoming barriers. Peer Support Specialists may assist with housing coordination, life skills education, emergency needs and numerous other areas of client support.



#### **Housing Services**



- OnTrack Rogue Valley's transitional and long-term housing communities are for individuals and households with a
  history of recovery who receive supportive services from a referring agency in the community. Tenants must be
  sober and in recovery.
- Only 35% of OnTrack's housing is occupied by OnTrack clients. The remaining 65% are clients from referring
  agencies who offer help for veterans, seniors, people with disabilities, those needing mental health services, and
  treatment services for recovery from alcohol and drug addictions.
- We have affordable studio, one- and two-bedroom apartments for rent in the Medford and Grants Pass areas.
   There is a waiting list for vacant units in these communities.
